Response #10	Reading quizzes due before class or clicker quizzes about readings that would reward the readers of the class.
Response #11	I found the pre-class quizzes to be both helpful for when the exams came and for encouraging everyone to do the readings. There were quite a few pre-class quizzes in the beginning of the semester, then none at the end. I think this caused everyone to become lackadaisical with the readings, when before we would get an idea of what was important to focus on for exams and would get credit for doing the readings. When neither of these two incentives were present, participation and enthusiasm dropped.
Response #12	An incentive for me would be integrating them more into the course, meaning like more quizzes or having to use them to write the papers. When I know I need the reading for something, I more likely to do it!
